## Synchronization and exchanging master data across multiple tenants and databases

The application ensures data consistency when replicating data between multiple Dynamics 365 Business Central databases.

For this purpose, Master Data Management System offers functions that enable the user to set up any set of data within Dynamics 365 Business Central database and replicate it to another Dynamics 365 Business Central database.

- Data synchronization (across any tables) between the subsidiaries and standalone databases
- Integration of the contact data base
- Standardization of master data, e.g. inventory numbering chart of accounts or customers
- Ensuring data consistency by blocking modifications to global data

# Parallel posting, manufacturing, cost allocation and calculation

The application enables the accurate calculation and posting of manufacturing costs through cost allocation, cost variance allocation, and parallel posting functionality.

- The parallel posting functionality to record costs based on cost types and business function
- The cost allocation functionality to assign common indirect costs to different business units, processes and products
- Valuating the actual cost of production of finished products
- Assigning default dimensions to a combination of inventory journal line type and combination of posting groups
- The allocation of manufacturing cost variances

## Products customization for manufacturing and trading companies

Advanced Product Configurator allows you to create item cards, item variants, production BOMs, routings and orders with the use of predefined attributes, attribute values and dependencies between the attributes.

The solution can be implemented both in a trading company, where the products and product sets are typically assembled to meet the specific needs of a particular customer, and in a manufacturing company, where the parameters of produced goods must be compatible with an individual customer order.

- Creating items, item variants and production orders whenever needed, without the necessity to store redundant item variants in the system
- Preventing the user from entering erroneous combinations of attribute values
- Automatic creation of component lists based on attribute values and the calculation of quantities required to produce configurable items
- Defining multiple attributes, possible attribute values and dependencies between the attributes
- Automatic calculation of sales prices
- Automatic creation of item numbers and variants, multilingual descriptions and extended texts, as well as calculations of item weight and units of measure

## Bonuses & Accruals

# Retrospective bonuses and rebates with real-time accruals posting

The application supports calculation of discounts that are granted after issuing a sales invoice or purchase invoice. This type of discount is called a retrospective discount which means it is based on sales targets that have been met. The solution is also used to register other calculations based on sales or purchase amounts and quantities – such as commissions for sales staff and sales representatives, loyalty programs, royalties, etc.

- Functionality for bonuses that are granted after an invoice is posted, i.e. rebates (retrospective payment)
- Setting up and managing bonus types, bonus calculation setup, bonus recipients, periods for which bonuses are to be calculated, and recurring bonuses and automatic creation of new bonus cards
- Recording other bonuses / rebates calculated based on the sales / purchase amount and sales / purchase quantity
- Settling bonus by issuing a sales credit memo or purchase invoice
